NEW BUSINESS CAPITAL RESERVES

Mrs. Corless moved that, upon recommendation of the Superintendent of Schools, that the Board of Education authorizes the Superintendent of

> Schools, in the event there are sufficient funds remaining in the 2019/2020 budget, to transfer an amount not to exceed \$3,500,000 from the General Fund to the Capital Reserve Fund established in June 2020 on or before

Iune 30, 2020.

Mr. Ferrara seconded and the motion was carried 5-0.

MOA/CSEA CLERICAL-CAFETERIA UNIT

Mr. Ferrara moved, that the Board of Education approve a Memorandum of Agreement between North Bellmore Union Free School District and CSEA, Local 1000 AFSCME, AFL-CIO North Bellmore UFSD Clerical/Cafeteria Unit Nassau County Education Local 865 dated June 25, 2020 regarding unused vacation leave and make up for spring recess. Mrs. Corless seconded and the motion was carried 5-0.

MOA/PRINICPALS' ASSOCIATION

Mrs. Corless moved that the Board of Education approve a Memorandum of Agreement between North Bellmore Union Free School District and CSEA, Local 1000 AFSCME, AFL-CIO North Bellmore UFSD Principals Association dated June 25, 2020 regarding unused vacation leave and make up for spring recess. Mrs. Cmar-Grote seconded and the motion was carried 5-0.

EMPLOYMENT AGREEMENTS

Mrs. Erhard moved that the Board of Education approve an Employment Agreement between North Bellmore Board of Education and Jacqueline Rehak for the term: July 1, 2020 – June 30, 2023. Mrs. Cmar-Grote seconded and the motion was carried 5-0.

Mrs. Corless moved that the Board of Education approve an Employment Agreement between North Bellmore Board of Education and Helena McKenna for the term: July 1, 2020 – June 30, 2022. Mr. Ferrara seconded and the motion was carried 5-0.

Mr. Ferrara moved that the Board of Education approve a Memorandum of Agreement between North Bellmore Board of Education and Marie Testa dated June 25, 2020 regarding a one year extension and adjustment to the rollover of unused vacation. Mrs. Corless seconded and the motion was carried 5-0.

Motion was made by Mrs. Corless to approve the following resolution: WHEREAS, the District and the Cafeteria/Clerical Unit have entered into an agreement pertaining to the rollover of unused vacation time and a makeup for spring recess in light of the circumstances surrounding the COVID-19 Pandemic; and

WHEREAS, the District would like to extend a similar benefit to 2 non-aligned employees.

NOW THEREFORE, BE IT RESOLVED, that non- aligned employees, Jeanne Canavan and Barbara Fillios, shall be permitted to receive payment for up to five(5) unused vacation days during the 2019/20 school year; shall be

permitted to roll over into the 20/21 school year any unused vacation time remaining during the 2019/20 school year; and shall be off from July 6, 2020 through July 10, 2020, or August 17, 2020 through August 21, 2020, and one additional floating holiday scheduled in conjunction with approval provided by the employees' direct supervisor to make up for spring recess during which they were required to work.

Mrs. Cmar-Grote seconded and the motion was carried 5-0.

SUMMER TRANSPORTATION CONTRACT

Mrs. Corless moved that the Board of Education renew the following 2020 Summer Transportation Contracts at the revised CPI rate for in-district transportation and revised rate for private school transportation with: Suburban Bus Transportation Inc. Mr. Ferrara seconded and the motion was carried 5-0.

CENTRAL OFFICE ADMINISTRATORS

Mrs. Cmar-Grote moved that in light of the circumstances created by the COVID-19 Pandemic, and in consideration of the fact that central office administrators have been unable to take vacation time during the pandemic periodic, all central office administrators shall be permitted to carry over into the 2020/21 school year any unused vacation time left over from the 2019/20 school year. Mrs. Corless seconded and the motion was carried 5-0.

TRANSPORTATION SETTLEMENT AGREEMENT
